## > Compliance with Laws and Regulations

All suppliers are obligated to comply with the applicable national and international laws, regulations, and standards. This specifically includes:

- Provisions of labor law,
- Environmental laws,
- · Regulations on product safety,
- Compliance requirements, including measures against corruption, bribery, and money laundering.

#### > Human Rights and Working Conditions

Respect for human rights and the maintenance of fair and safe working conditions are fundamental principles:

- Prohibition of Child and Forced Labor:
   Suppliers must not tolerate any forms of child labor or forced labor.
- Working Hours and Compensation: Compliance with applicable legal regulations regarding working hours and minimum wages must be ensured.
- Non-Discrimination: Any form of discrimination, whether based on gender, age, ethnic origin, religion, disability, sexual orientation, or other characteristics, is prohibited.
- Health and Safety: Suppliers must provide safe and hygienic working conditions and implement measures to prevent accidents and occupational illnesses.

#### > Environmental and Climate Protection

Suppliers actively contribute to the conservation of natural resources and the reduction of environmental impact:

- Suppliers are expected to operate an effective environmental management system.
- Resource Conservation: Materials and energy should be used efficiently, and emissions as well as waste should be minimized.
- Hazardous Substances: The handling of environmentally hazardous substances must be safe and comply with legal requirements.

### > Ethical Conduct and Integrity

A high level of integrity and ethical behavior is expected from all suppliers:

- Corruption and Bribery:
   Offering, accepting, or soliciting bribes or other improper benefits is strictly prohibited.
- Avoidance of Conflicts of Interest:
   Business decisions must be made free from personal or financial conflicts of interest.
- Confidentiality and Data Protection:
   The confidentiality of information belonging to
   Werkzeugbau Berger GmbH and its business
   partners must be safeguarded, and data
   protection must be ensured in compliance
   with legal requirements.
